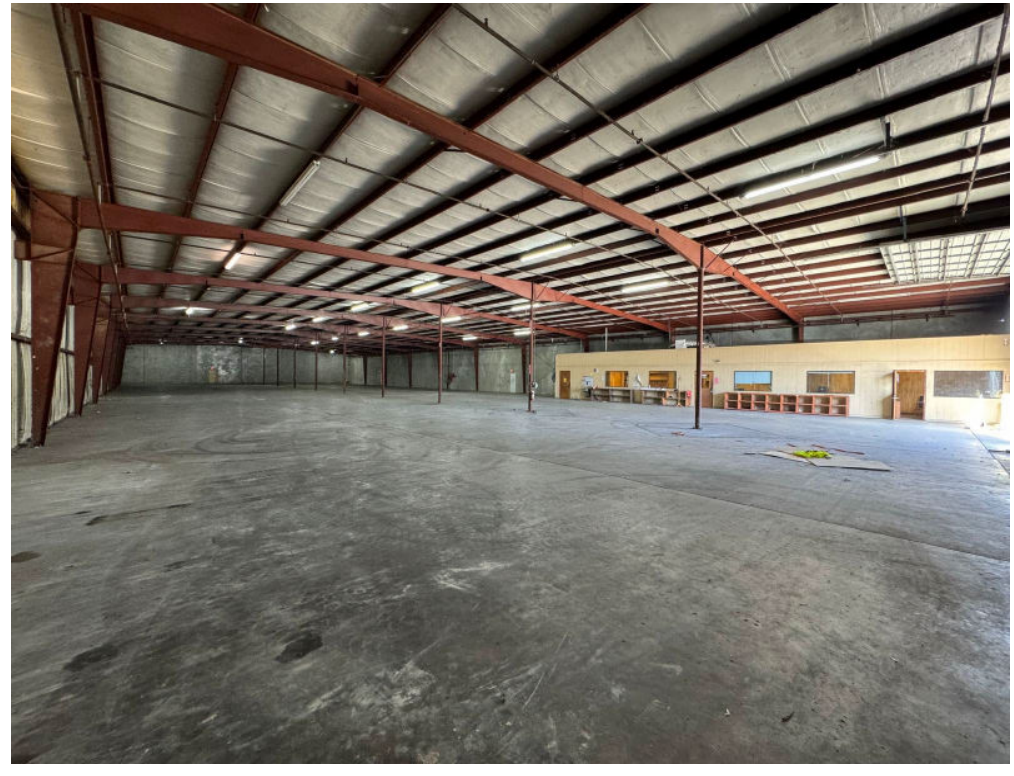
Outside Storage Breakdown + Neighboring Tenants



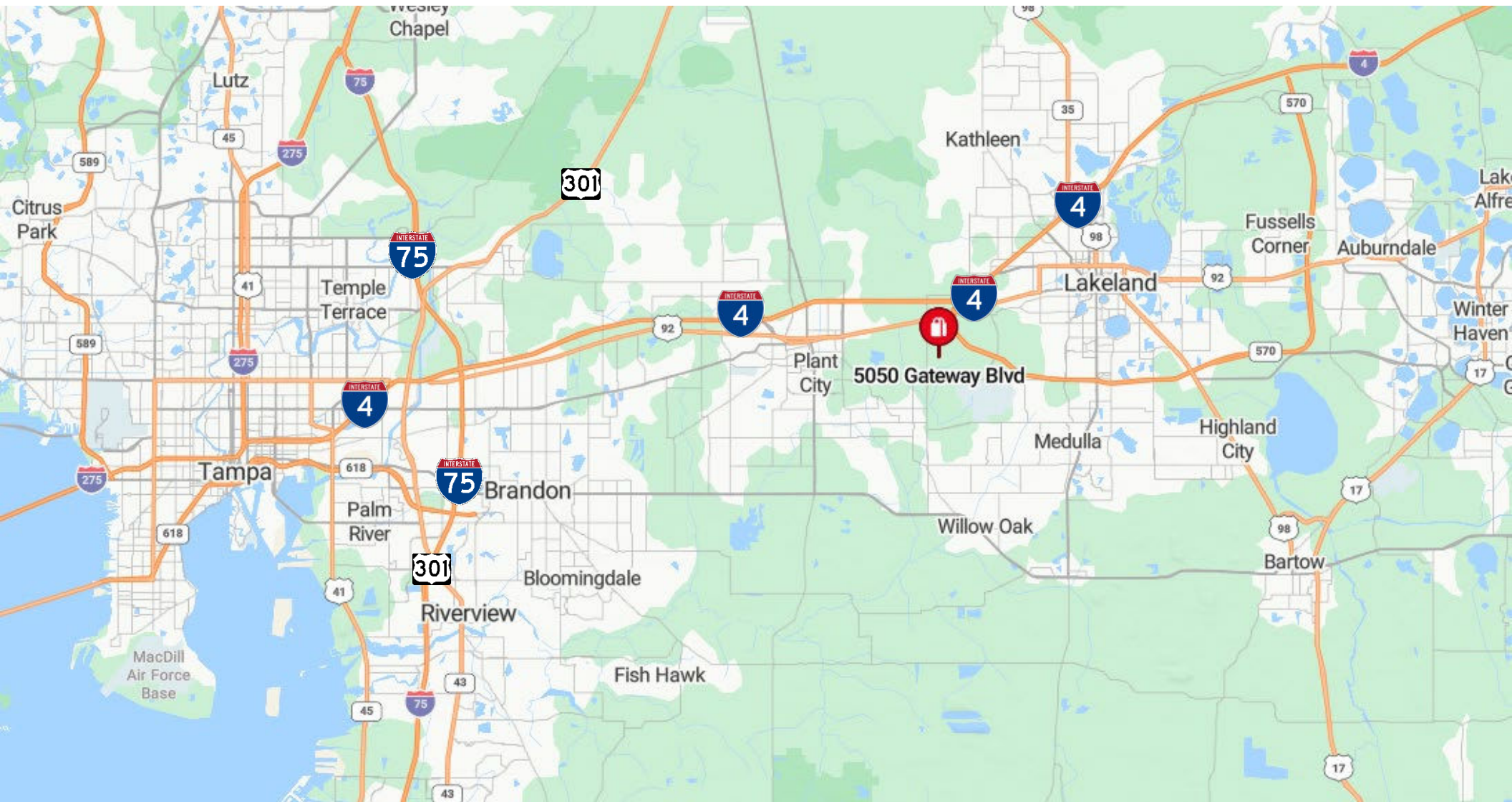
